NOW, THEREFORE, BE IT PROCLAIMED BY JUDGE KEN SCHAWE OFCALDWELL COUNTY!

That a local state of disaster is hereby declared for CALDWELL COUNTY pursuant to §418,108(a) of the Texas Government Code.

Pursuant to §418.018(b) of the Texas Government Code, the state of disaster shall continue for a period of not more than seven days from the date of this declaration unless continued or renewed by the Commissioners Court of Caldwell County.

Pursuant to §418.018(c) of the Texas Government Code, this declaration of a local state of disaster shall be given prompt and general publicity and shall be filed promptly with the County Clerk.

Pursuant to §418.018(d) of the Texas Government Code, this declaration of a local state of disaster activates the Caldwell County emergency management plan.

Pursuant to § 418.018 (f) I hereby order persons to vacate low lying areas threatened by flooding along the San Marcos River and direct the Sheriff's Office to make every effort to remove those persons.

That this proclamation shall take effect immediately from and after its issuance.

WHEREAS, the City of Luling on the 24th day of May 2015, has suffered widespread or severe damage, injury, or loss of life or property resulting from flooding and

WHEREAS, Mike Hendricks County Mayor of the City of Luling has determined that extraordinary measures must be taken to alleviate the suffering of people and to protect or rehabilitate property,

NOW, THEREFORE, BE IT PROCLAIMED BY Mayor Mike Hendricks of Luling:

That a local state of disaster is hereby declared for City of Luling pursuant to §418.108(a) of the Texas Government Code.

Pursuant to §418.018(b) of the Texas Government Code, the state of disaster shall continue for a period of not more than seven days from the date of this declaration unless continued or renewed by the City Council.

Pursuant to §418.018(c) of the Texas Government Code, this declaration of a local state of disaster shall be given prompt and general publicity and shall be filed promptly with the City Secretary.

Pursuant to §418.018(d) of the Texas Government Code, this declaration of a local state of disaster activates the City of Luling emergency management plan.

Pursuant to § 418.018 (f) I hereby order persons to vacate low lying areas threatened by flooding along the San Marcos River and direct the Luling Police Department to make every effort to remove those persons.

That this proclamation shall take effect immediately from and after its issuance.

RESOLUTION

STATE OF TEXAS
COUNTY OF CALDWELL

WHEREAS, Caldwell County on the 23rd and 24th day of May, 2015 suffered widespread or severe damage, injury, or loss of life or property resulting from historic flash flooding; and

WHEREAS, the County Judge, considering a Proclamation Declaring Caldwell County a Local Disaster Area necessary to promote the preservation of life and property, executed such a Resolution on or about May 24, 2015; and

WHEREAS, §418.108 of the Texas Government Code provides that the County Judge's Proclamation may not remain in effect in excess of seven (7) days unless consent to continue it or renew it is provided by vote of the Caldwell County Commissioners Court; and

WHEREAS, the County Judge's Proclamation was, and this Resolution is, declared for the purpose of continuing the measures that must be taken to alleviate the suffering of people, to protect or rehabilitate property within Caldwell County and continuing a collective effort of state and local entities to provide disaster relief; and

NOW, THEREFORE, BE IT RESOLVED that this Resolution continuing the County Judge's Declaration of Local Disaster executed on or about May 24, 2015 is hereby declared and shall continue for a period of no longer than thirty (30) days' from the date cited below, unless this Local State of Disaster is continued by resolution of the Caldwell County Commissioners Court.
