Judge Schawe led all present in the Pledge to both flags.

Announcements. Items or comments from Court Members or Staff.

Commissioner Munoz announced that the Memorial Service at the cemetery was very touching and commended Dave Francis for what he did. Also, tomorrow (May 27<sup>th</sup>) at 10:00 a.m., Rep. John Cyrier is having a resolution read for Liz McGinty who was very involved in the community. Commissioner Munoz also commended all the First Responders, Volunteer Firefighters, Martin Ritchey, American Red Cross, and all volunteers who helped with the floods in the area. Commissioner Moses also commended VFD and Martin Ritchev for all they did. He also thanked the Unit Road Dept., Luling Fire Dept., Luling Police Dept., EMS and the Sheriff's Dept. for being on hand during the flooding. Commissioner Madrigal thanked Martin Ritchey for working with the Firefighters and volunteers for their actions evacuating people from their homes with no casualties. Commissioner Roland thanked all emergency helpers and the Unit Road Dept. for all their hard work. Commissioner Madrigal also thanked Dwight Jeffery and all his crew for the work that they did. Judge Schawe commented that one positive for him was seeing how everyone from state and county levels to volunteers how they came together for endless hours to get the job done. He could not thank Martin Ritchey enough for all he did.

Martin Ritchey commented that there were hundreds of volunteers over the past few weeks and past few days who worked tirelessly to help rescue and evacuate people. There were a number of rain events this month with resources being sent out to Hays Co. and Bastrop Co. in weeks prior to Caldwell County flooding. On Friday, plans were made with the Fire Chiefs and swift water rescue to come up with a plan of attack and implementation of that plan. Surrounding counties played a big part in getting real time weather reports together to make decisions to evacuate. Without all these teams working together to evacuate people along the river there would have been great loss of lives. Fifty to sixty emergency rescues, including helicopters. were made. There were 330,000 people who went to the Facebook page for information, some as far away as Australia, to offer prayers and support. This recovery will be long and deep. The County and State have been declared a disaster. The next steps will be recovery and damages accessed for the county and state. Before he left, Martin recommended leaving the burn ban off.

She addressed the court about prior flooding in the subdivision in 1985-1986 after which a berm was added. This subdivision is not in the river plain. After the flood of 1998 the berm is no longer working. Ms. McDonald asked the court for assistance with repairing the berm or water drainage issues.

Cory McDonald, Country Glen Subdivision, spoke to the court about the 10 ft. County easement in the back of the property that could allow the County access to relieve some problems. He spoke of concerns with the Walton Group adding a subdivision next to the County Glenn Subdivision and the drainage issues it will create. Minor things could be done to make major improvements. Any help would be appreciated.
