<u>WORKSHOP</u> (No Action): Report from program manager on remodeling of the new Caldwell County Judicial and Service Center. No action will be taken at this time.

Project Manager Les Reddin updated the Court on the progress of the new Justice Center. The staining of the woodwork in the Courtrooms was in progress and the color was matching very well with the woodwork in the rest of the hall. The concrete for the front walkway was beginning to be poured and the back road and fire lane will begin soon. The Court discussed grand opening events for December 15 after Commissioners Court. This would be the first meeting of the month. Perhaps the Commissioners could show their constituents around the building and light refreshments would be served. County Clerk Carol Holcomb discussed the lack of rollers on the shelves in Deed Records. The weight of the books being removed cause concerns. There are possible solutions to alleviate this and they are being looked into. The benches in the grand hall are going to be covered with pecan wood. The wood will be from trees in Caldwell County. The next report is scheduled for November 10, 2014.

Commissioner Buchholtz said that he had attended a meeting of the Caldwell County Family Violence Task Force on Friday. It was held at the Connection Center on Church St., in Lockhart. About 100 people were in attendance and it was a very productive meeting. He also announced that County Auditor Larry Roberson had won the raffle at the Delhi Volunteer Fire Department Fund Raiser this past weekend. Commissioner Roland told everyone that the County had been invited to West Columbia, Texas for a grave marking for Byrd Lockhart, the County's namesake. Judge Bonn and Commissioner Buchholtz said that they knew of a few of the Lockhart City Council that were planning to attend. Commissioner Roland also recognized Constable Villareal and his deputies from Pct. 4 for providing their service in Dale for the Halloween festivities this past Saturday night. Texas AgriLife Extension Service Report – Carissa Wilhelm/ Michael Haynes Michael Haynes reported the activities that had taken place in September and the status of the upcoming events. He discussed the market for beef cattle at this time with Judge Bonn and said that he was glad for the beef producers in Caldwell County.

Greater San Marcos Partnership Report – Adriana Cruz

Commissioner Madrigal asked about if the residents in the ETJ would be required to follow City of San Marcos permitting rules and she assured him that the interlocal pertained to new subdivisions only. A.D.A. Mack Harrison told the Court that there could be amendments with mutual agreement. Commissioner Madrigal explained that he is comfortable with signing the agreement knowing that there can be amendments made. Motion made by Commissioner Madrigal, second by Commissioner Roland to enter into an interlocal agreement for subdivision regulation within extraterritorial jurisdiction of City of San Marcos. She read just a few of the recorded items in the books dated from the 1800's and read them to the Court.
