## Call Meeting to Order.

Judge Schawe calls the meeting to order at 9:00 a.m. All members are present.

Invocation. Lockhart Ministerial Alliance

Minister Steve Digby from First Christian Church Lockhart opens the meeting in prayer.

<u>Pledge of Allegiance to the Flags.</u> (Texas Pledge: Honor the Texas Flag; I pledge allegiance to thee, Texas, one state under God, one and indivisible).

Judge Schawe leads all present in the pledge to both flags.

Announcements. Items or comments from Court members or staff.

Commissioner Wright announces his mother is turning 89 and introduces Bob Bush.

**Bob Bush** introduces the three new County employees; Purchasing Agent Danielle Blake, Assistant Extension Agent Wayne Morse, and Grand Writer Dennis Engelke.

**Commissioner Moses** thanks Minister Digby and says he attended National Night Out events in Luling and McMahan, and fundraisers at McMahan's VFD and St. John's Catholic Church. He says upcoming events are Night in Old Luling, a quilt show, and Delhi VFD Cook off.

**Commissioner Theriot** says he attended a landowner meeting and a Martindale City Council Meeting, and that CAMPO has road funds open and is calling for project recommendations.

**Commissioner Roland** says happy birthday to Commissioner Wright's mother and that he attended multiple Night Out events, and has been very busy this election period.

**Barbara Gonzales** passes a document to court members (not provided to the County Clerk for minutes), discusses work on the budget, and says a FEMA representative met with her office and Dennis Engelke.

Motion made by Commissioner Roland, second by Commissioner Wright that we leave the burn ban off. All voting "Aye".

4. Discussion/Action to approve a Proclamation declaring October 7-13, 2018 as National 4-H Week in Texas. Cost: None; Speaker: Judge Schawe / Elsie Lacey; Backup: 1.

Toni Martinez is introduced and reads the Proclamation. Commissioner Theriot exits.

Motion made by Commissioner Moses, second by Commissioner Roland to approve the Proclamation. All present voting "Aye".

5. Discussion/Action to approve a Proclamation declaring Texas Extension Education Association (TEEA) Week October 7-13, 2018. Cost: None; Speaker: Judge Schawe / Elsie Lacey; Backup: 1.

Elsie Lacey introduces the TEEA Club. Judy Wheeler explains the TEEA Club and reads the Proclamation. The Club members introduce themselves. Commissioner Theriot returns.

Motion made by Commissioner Roland, second by Commissioner Moses that we approve the Proclamation declaring Texas Extension Education Association Week as October 7-13, 2018.

17. <u>PUBLIC HEARING at 9:30AM</u>: concerning the approval of a Final Plat for Tower Meadows subdivision to include 23 lots on approximately 78.438 acres off Tower Road and Black Ankle Road. Cost: None; Speaker: Commissioner Wright / Kasi Miles; Backup: 4.

The Public Hearing opens at 9:33 a.m.

Kasi Miles provides background for the hearing, opens it to the public, and answers questions from court members.

Linda Hinkle, with Hinkle Surveyors, says the designs meet the new standard and that deed restrictions will be put into place.

Robert Lewis lives on Fox Lane and asks the court who will enforce the restrictions.

Jim Chisolm owns a ranch across from Tower Meadows and says he is concerned about the surrounding roads needing improvement and that the utilities required for a subdivision will affect his land.

Johnny Smith lives on Fox Lane and says he is concerned about the subdivision entrances, drainage, easements, well water, septic tanks, and regulations being enforced.

The Public Hearing ends at 9:46 a.m.

 Discussion/Action to consider approval of a Final Plat for Tower Meadows subdivision to include 23 lots on approximately 78.438 acres located off Tower Road and Black Ankle Road. Cost: None; Speaker: Commissioner Wright / Kasi Miles; Backup: 13.

Commissioner Theriot, Kasi Miles, Judge Schawe, and Jacque Thomas discuss the concerns mentioned by the speakers in the Public Hearing. Kasi Miles confirms that she recommends approval.

Motion made by Commissioner Wright, second by Commissioner Theriot that we approve the Final Plat for Tower Meadows. All voting "Aye".

6. **Discussion/Action** to approve a Proclamation declaring October as Domestic Violence Awareness Month. **Cost: None; Speaker: Judge Schawe; Backup: 1.** 

Ashley Rios, Children's Counselor with HCWC, Cindy Gonzales, Victim's Assistance Coordinator in the District Attorney's Office, and Licia Edwards, Caldwell County Sheriff's Office Victim's Services introduce themselves and read the Proclamation.

So moved by Commissioner Moses, second by Commissioner Roland. All voting "Aye".

 Discussion/Action to approve Resolution 14-2018 making an appointment to the Capital Area Housing Finance Corporation for a four year term. Cost: None; Speaker: Judge Schawe; Backup: 1.

Judge Schawe reads the Resolution and asks for a motion. Motion made by Commissioner Wright, second by Commissioner Roland. All voting "Aye".

Judge Schawe encourages people to contact Capital Area Housing Finance Corporation with suggestions for a donation they are planning.

8. Discussion/ Action to approve Resolution 15-2018 for participating in the 2019 - 2023 Austin -Round Rock Metropolitan Statistical Area (MSA) Regional Air Quality Plan. Cost: \$3,850.00; Speaker: Judge Schawe; Backup: 3.

Judge Schawe explains the item, and Commissioner Wright says he has attended their quarterly meeting.

Motion made by Commissioner Wright, second by Commissioner Theriot that we approve the resolution participating in the 2019 - 2023 Austin - Round Rock Metropolitan Statistical Area Regional Air Quality Plan.

Jacque Thomas inquires about the meetings' future attendance. Judge Schawe discusses local air quality and it's relation to government funding. All voting "Aye".

9. Discussion/Action on adding a phone stipend for the "Purchasing Agent" and "Grant Writer" Position(s) to the FY 2019 Budget. Cost: TBD; Speaker: Judge Schawe; Backup: None.

Judge Schawe introduces Barbara Gonzales to explain the item and discusses options with court members.

Motion made by Commissioner Wright, second by Commissioner Moses that we approve a phone stipend for these two positions at a start of \$35.00 per month. All voting "Aye".

10. Discussion/Action regarding the condition of the Justice Center roof. Cost: TBD; Speaker: Judge Schawe; Backup: 11.

Judge Schawe explains what has been done and what will be needed in the future, noting that finances should be planned for. Court members discuss the situation. No action is taken.

11. Discussion/Action regarding the lease of the Slater Building in Luling with Texas Department of Public Safety (DPS). Cost: None; Speaker: Judge Schawe; Backup: 13.

The court discusses why the building is named Slater. Judge Schawe asks for a motion for himself and Amanda Montgomery to continue negotiations. So moved by Commissioner Theriot, second by Commissioner Moses. All voting "Aye".

12. Discussion/Action regarding the renewal of the lease of 9675 State Highway 142 in Maxwell for Precinct 3 Justice of Peace. Cost: TBD; Speaker: Judge Schawe; Backup: None.

Judge Schawe explains the County is attempting to purchase the property or change the rental contract and asks for a motion to table. So moved by Commissioner Theriot, second by Commissioner Moses. All voting "Aye".

13. Discussion/Action regarding the payout of 48.20 hours of accrued vacation time for the Sanitation Director. Cost: TBD; Speaker: Judge Schawe; Backup: 3.

Judge Schawe and Commissioner Theriot explain the situation and Judge Schawe asks for a motion to approve. Motion made by Commissioner Roland, second by Commissioner Moses.

Commissioner Wright, Judge Schawe, and Barbara Gonzales discuss the situation further including how it exists and is being corrected. All voting "Aye".

14. Discussion/Action to approve the Caldwell County Employee Handbook as updated, effective October 1, 2018. Cost: None; Speaker: Judge Schawe; Backup: 78.

Bob Bush says the changes were included in the backup, reviews several of them, and requests approval.

Motion made by Commissioner Wright, second by Commissioner Theriot that we approve the changes to the Caldwell County Employee Handbook. All voting "Aye".

Discussion/Action to schedule a special meeting for the purpose of canvassing the November 6, 2018 General Elections. Cost: None; Speaker: Judge Schawe / Pamela Ohlendorf; Backup: None.

Judge Schawe shares the dates the Elections Office requested and the court discusses Monday November the 19<sup>th</sup>.

So moved by Commissioner Roland, second by Commissioner Moses. Judge Schawe confirms the motion is to have the votes canvassed Monday November 19<sup>th</sup>. All voting "Aye".

16. Discussion/Action to reschedule the second meeting of Commissioners Court to meet the requirements for canvassing the November 6, 2018 General Elections. Cost: None; Speaker: Judge Schawe / Pamela Ohlendorf; Backup: None.
