Judge Schawe calls the meeting to order at 9:00 a.m. All members are present.

Judge Schawe and Commissioner Theriot explain that the presentation will be rescheduled.

Carine Chalfoun recommends leaving the burn ban off. Motion made by Commissioner Wright, second by Commissioner Roland to accept Carine's recommendation. All voting "Aye".

Discussion/Action authorizing the County Judge to enter into a Supplemental Agreement to Interlocal Cooperative Agreement between Caldwell County and City of San Marcos for Subdivision Regulation Within the Extraterritorial Jurisdiction of the City of San Marcos regarding development review of an approximate 53-acre tract located at FM 142 near Church Street in Maxwell. **Cost: None; Speaker: Commissioner Theriot; Backup:**

Judge Schawe, Commissioner Theriot, and Bluebonnet Electric representative Matt Bentke explain and discuss the agreement.

Motion made by Commissioner Theriot, second by Commissioner Moses to authorize the Judge to execute a Supplemental Agreement to Interlocal Cooperative Agreement between Caldwell County and City of San Marcos for Subdivision Regulation Within the ETJ of the City of San Marcos. All voting "Aye".

7. **Discussion/Action** regarding a plan to combine Caldwell County's Public Service Announcement Points (PSAP's) and presentation. **Cost: None; Speaker: Judge Schawe; Backup: None.**

Judge Schawe introduces CAPCOG representatives Martin Ritchey and Betty Voigt who explain how PSAPs work and potential benefits to combining them. Court members discuss options for the next step and Mike Lane recommends all entities involved being brought together to confirm if they support the combination idea.

Motion made by Commissioner Theriot, second by Commissioner Moses that we move forward. All voting "Aye".

8. **Discussion/Action** to adopt an Interlocal Cooperative Agreement between Caldwell County and the City of Lockhart for the regulation of subdivisions within the Extraterritorial Jurisdiction of the City of Lockhart, pursuant to Section 242.001(d)(1) of the Texas Local Government Code. **Cost: None; Speaker: Judge Schawe; Backup: 16.**

Judge Schawe explains the item and confirms information with Amanda Montgomery. Motion made by Commissioner Theriot, second by Commissioner Roland to approve Interlocal Cooperative Agreement between Caldwell County and the City of Lockhart for the regulation of subdivisions within the ETJ. All voting "Aye".

9. **Discussion/Action** to authorize the County Judge to execute a Chapter 381 Economic Development Incentive Agreement between Visionary Fiber Technologies and Caldwell County for purposes of local economic development through a tax rebate incentive. **Cost: TBD; Speaker: Judge Schawe; Backup: 29.**

Adriana Cruz reviews what VFT does and what their Chapter 381 Economic Development Incentive Agreement entails. VFT's owner John Kinzer introduces himself and answers the court's questions.

Motion made by Commissioner Wright, second by Commissioner Moses that the Judge be authorized to execute a Chapter 381 Economic Development Incentive Agreement between Visionary Fiber Technologies and Caldwell County for purposes of local economic development through a tax rebate incentive. All voting "Aye".

10. **Discussion/Action** to approve the nominations to the Plum Creek Conservation District Board of Directors for a four-year term. **Cost: None; Speaker: Judge Schawe; Backup: 2.**

Recommendation by Commissioner Theriot, second by Commissioner Wright that we recommend the reappointment of Ben Twidwell and the appointment of Tom Owens to the Plum Creek Conservation District. All voting "Aye".

Discussion/ Action to approve Budget Amendment #1, Fiscal Year 2018-2019 decreasing budget line item(s) 001-6510-4860 / Contingency in the amount of \$5,829 and 001-6510-4863 / Overtime Contingency in the amount of \$5,605; and approve the increased budget line item(s) 009-1000-2140 / Uniform Stipend in the amount of \$5,200, 009-1000-1150 / Overtime in the amount of \$5,000, 009-1000-2010 / Social Security & Medicare Tax in the amount of \$781 (\$398 + \$383), 009-1000-2030 / Retirement \$453 (\$231 + \$222), 001-9000-4961 / Transfer to Courthouse Security in the amount of \$11,434 and 009-7000-1000 / Transfer from General Fund in the amount of \$11,434. The total cost will be \$11,434 'Transfer from the General Fund to Transfer to Courthouse Security Fund. Cost: \$11,434.00; Speaker: Judge Schawe; Backup: 1.

Judge Schawe reviews the item and asks for approval. Motion made by Commissioner Roland, second by Commissioner Moses to approve item 11. All voting "Aye".

12. Discussion/Action to approve Budget Amendment # 2 decreasing budget line item 001-6510-4863 / Overtime Contingency in the amount of \$1,120; and increasing budget line item(s) 001-2130-1150 / Overtime Contingency in the amount of \$1,000, 001-2130-2010 / Social Security & Medicare in the amount of \$76, and 001-2130-2030 / Retirement in the amount of \$44 netting a \$0 cost to General Fund, (Decreasing Non-Departmental Overtime Contingency / Increasing County Auditor Overtime). Cost: None; Speaker: Judge Schawe; Backup: 1.

Judge Schawe reads the item. So moved by Commissioner Moses, second by Commissioner Theriot. All voting "Aye".

23. Discussion/Action to authorize Resolution 21-2018 certifying the reallocation of surface transportation block grant funding and committed matching funds to the Capital Area Metropolitan Planning Organization (CAMPO) for the FM 150/Yarrington Road project. Cost: TBD; Speaker: Commissioner Theriot; Backup: 22.

Commissioner Theriot and CAMPO Executive Director Ashby Johnson explain the item.

Recommendation made by Commissioner Theriot, second by Commissioner Wright to authorize Resolution 21-2018 certifying the reallocation of surface transportation block grant funding and committed matching funds to the Capital Area Metropolitan Planning Organization for the FM 150/Yarrington Road project. All voting "Aye".

13. Discussion/Action regarding the Certificates of Obligation expenditure list items. Cost: TBD; Speaker: Judge Schawe; Backup: 1.

Judge Schawe, Commissioner Wright, Donald LeClerc, Commissioner Roland, Mike Lane, Barbara Gonzales, and Commissioner Moses discuss items the funds could potentially purchase along with a written proposal being created.

Motion made by Commissioner Wright, second by Commissioner Roland to approve these expenditures. All voting "Aye".

14. Discussion/Action regarding the engagement letter with Rutledge, Crain & Company, PC for the purposes of financial statements auditing for the year ended September 30, 2018. Cost: The cost is not to exceed \$29,750 for the financial statements, and an estimate of \$7,500 to conduct and report on the single audit; Speaker: Judge Schawe / Barbara Gonzales; Backup: 8.

Barbara Gonzales recommends retaining Rutledge, Crain & Company and she and Judge Schawe discuss whether an RFP is required. Judge Schawe recommends moving forward.

Motion made by Commissioner Wright, second by Commissioner Theriot. All voting "Aye".

15. Discussion/Action to approve Final Draft Request for Proposal (RFP) for Administration and Professional Services of General Land Office – Community Development Block Grant (GLO-CDBG) funding. Following approval of RFP final draft, RFP advertisement will be conducted on November 15th, 2018 & submission deadline of proposals is Nov. 26th, 2018. Cost: None; Speaker: Judge Schawe / Danie Blake; Backup: 28.

Danie Blake requests approval for the item and discusses items 15-17 with Judge Schawe. Motion made by Commissioner Roland, second by Commissioner Moses that we approve item 15. All voting "Aye".

16. Discussion/Action to approve Final Draft Request for Proposal (RFP) for Management Services for Caldwell County Hazard Mitigation Projects/Funding. Following approval of RFP final draft, RFP advertisement will be conducted on November 15th, 2018 and submission deadline of proposals is November 26th, 2018. Cost: None; Speaker: Judge Schawe / Danie Blake; Backup: 25.

Judge Schawe asks for a motion to approve. So moved by Commissioner Moses, second by Commissioner Roland. All voting "Aye".

17. **Discussion/Action** to approve Final Draft of Request for Qualifications (RFQ: 18CCP01A) for the TCEQ-LID 319 Grant - Construction Manager at Risk Project. Succeeding approval of final draft, Purchasing Agent will notify the public of RFQ:18CCP01A. All statements of qualifications will be submitted to the Purchasing Agent no later than the deadline of November 28, 2018 at 2:00 p.m. **Cost: None; Speaker: Judge Schawe / Danie Blake; Backup: 35.**

Judge Schawe, Danie Blake, and Commissioner Theriot discuss the RFQs being sent out, the project being over budget, and that the RFQs are not a commitment to the project.

Motion made by Commissioner Theriot, second by Commissioner Roland to approve final draft of RFQ. All voting "Aye".

18. Discussion/Action to approve Final Draft of Request for Qualifications (RFQ: 18CCP01B) for the TCEQ-LID 319 Grant – Design Build Project. Succeeding approval of final draft, Purchasing Agent will notify the public of RFQ:18CCP01B. All statements of qualifications will be submitted to the Purchasing Agent no later than the deadline of November 28, 2018 at 2:00 p.m. Cost: None; Speaker: Judge Schawe / Danie Blake; Backup: 35.

Motion made by Commissioner Roland, second by Commissioner Theriot to approve item 18. All voting "Aye".

Motion made by Commissioner Wright, second by Commissioner Moses. All voting "Aye".

Dennis Engelke explains the item and asks for acceptance. So moved by Commissioner Moses, second by Commissioner Theriot. All voting "Aye".

21. Discussion/Action to approve pursuing an application for the Texas General Land Office Community Development and Revitalization Program grant as distributed through the Capital Area Council of Governments Community Development Block Grant (CDBG) Disaster Recovery funds initiative. Judge Schawe explains his progress negotiating the rental agreement and recommends accepting the lease while looking for another property.
